## CIMIRACEMOSIDE-C IN BLACK COHOSH BY HPLC ELSD

**FOR:** RAW MATERIALS, FINISHED DOSAGE FORMS

**BACKGROUND:** Recently Health Canada has sent a letter to Black Cohosh licensees requiring compliance to the modified requisites of accurately identifying *Actaea racemosa*. These efforts are to ultimately eliminate the cross-contamination of other *Actea* and *Cimicifuga* species within such Black Cohosh products. According to Health Canada, because other *Actea* and *Cimicifuga* species contain similar bio compounds such as 27-deoxyactein, current testing protocols may need additional or more specific testing to identify the sole presence of this botanical. Through their letter they've expressed concerns pertaining to the trend of Black Cohosh adulteration whether unintentional or deliberately for economic benefits. It is through these concerns that they have suggested the use of cimiracemoside C and cimifugin as analytes that may provide a more unambiguous method to verifying such uniqueness of *A. racemosa*. Several studies have demonstrated analytical methods of positively identifying Black Cohosh through the compound Cimiracemoside C because of its more select occurrence in the *A. racemosa* species. Conversely, the utility of cimifugin, a compound not present in Black Cohosh but is present in other *Actea* and *Cimicifuga* species, may provide additional non-detect support for the exclusive identity of *A. racemosa*. Among other entities enforcing *Actaea racemosa* identity is Australia's TGA.
